

NDT-CE 2022 – SPONSORING TERMS

Sponsoring Packages Bronze, Silver and Silver Premium

1 GENERAL

SVTI is the organizer of the International Symposium on Nondestructive Testing in Civil Engineering (NDT-CE) 2022, which we will refer to also as “the event” herein. SVTI has all authorizations and rights associated with the event, which seeks to continue the long tradition of the NDT-CE conference within the community of Nondestructive Testing in Civil Engineering. With a strong scientific focus, it typically brings together researchers and practitioners from many countries.

2 SUBJECT

The sponsoring terms also apply to exhibitors. The subject of these terms is the designation of a sponsor of the International Symposium on Nondestructive Testing in Civil Engineering.

Furthermore, the sponsor is also entitled to use the conference logo.

3 SERVICES PROVIDED BY THE ORGANIZER

The sponsor can choose from three different sponsoring levels: Silver Premium, Silver, and Bronze. For Gold Sponsors, customized premium arrangements are made hence this level of sponsoring is not covered within the boundaries of these terms.

Silver Premium

- Logo display on conference website and brochure (printed and digital)
- Advertisement space in conference brochure (printed and digital)
- 5 min presentation or video during conference opening session
- 4 full attendee registrations
- 1 exhibitor stand (or 1 additional attendee if the stand is not needed)

Silver

- Logo display on conference website and brochure (printed and digital)
- Advertisement space in conference brochure (printed and digital)
- 2 full attendee registrations
- 1 exhibitor stand (or 1 additional attendee if the stand is not needed)

Bronze

- Logo display on conference website and brochure (printed and digital)

Exhibition

(only applicable to Silver and Silver premium sponsors)

The exhibition will take place Aug 16-18, 2022 during the opening hours of the conference and will be located close to the conference rooms and break areas. Time slots will be provided for the delivery of goods. Every advertisement material or items brought to the conference by the sponsors must be removed by 15:00 (3 pm) on August 18th.

Exhibitor Stand:

- Standard furniture:
 - 1 Table (1,40 m x 0,70 m), ~5m²
 - 2 Chairs
- 1 Power outlet (220 V)

4 SPONSOR SERVICES

To support the event and in return for the services of the organizer, the sponsor will support the event by providing financial funds according to the selected sponsoring level:

- Silver Premium: EUR 5,000. -
- Silver: EUR 2,500. -
- Bronze: EUR 1,000. -

All prices exclude VAT (7.7%). Payment is made after the organizer has issued an invoice and is due on July 18, 2022. The payment can also be made in US dollars. However, the final cost varies based on daily exchange rates.

For packages including aspects of advertising content (Silver and Silver Premium), the sponsor bears the cost for the production and installation of advertising material for the sponsor.

The sponsor asks the organizer to start the services described in section 3 as soon as this agreement is signed, with no need for an additional approval of each individual measure or activity.

5 ADVERTISING CONTENT

This section only applies to sponsoring packages that include aspects of advertising content (Silver and Silver Premium).

The sponsor is generally free to design their advertisement. Some natural exclusions apply, particularly regarding:

- advertising that violates legal regulations
- advertising that harms the scientific integrity of the event or the reputation of the organizer

6 START, TERM, TERMINATION

These terms come into force on the day the sponsor commits to sponsoring the event and receives the certificate of sponsorship from the organizer. The terms end without the need for termination at the end of the event.

7 INSURANCE

Silver and Silver Premium sponsors take part in the exhibition at their own risk. Insurance is the exhibitor's own responsibility. The organizers do not accept liability for loss or damage of equipment.

8 CANCELLATION OF THE EVENT

The organizer is fully dedicated to holding the event. However, should circumstances occur that do not allow the event to be held, the organizer is not liable for damage due to a cancellation of the event.

In this case, any payment that has already been made must be repaid to the sponsor immediately.
